

### **The Commentator Challenge Promotion Terms and Conditions**

#### 1. INTRODUCTION

- 1. By entering this promotion, all participants will be deemed to have accepted these terms and conditions in full. All entry instructions form part of these terms and conditions.
- 2. The promotion is open to all persons, excluding employees of the promoter, its group companies, its agents or anyone professionally connected with this promotion and any member of their respective immediate families.
- 3. Competition entry opens at **12pm on 24 August 2020** and **closes at 11.59pm on 4 September 2020**. Entries received after this time and date will not be eligible to win a prize.
- 4. No purchase is necessary to enter the promotion. However, in order to enter the promotion, you must have capacity to film a video via a mobile phone and send the footage via e-mail to the promoter and administrator, the Henry Cecil Open Weekend.

#### 2. ENTRY TO THE PROMOTION

- 2. To enter the promotion, film a video of you commentating on The Sir Henry Cecil Commentator Challenge Stakes, footage available on the Henry Cecil Weekend website, and then send that to the Henry Cecil Open Weekend designated competition email address:

- 2. Entrants must commentate throughout the whole race
- 3. Only One entry per person

### 3. FINAL

- 1. The six finalists will be selected by the competitions judging panel. Judges' decision is final.
- 2. Finalists will be notified via email and/or telephone. In the event that the promoter is unable to contact a finalist within 2 working days of the relevant draw, the promoter reserves the right to award their place in the final to another contestant.
- 3. Each finalist will be required to commentate again on assigned races which will be sent directly to the persons by the promoter.
- 4. Each finalist agrees to have a JustGiving page set up in their name as part of the competition, with all donations received in aid of Racing Welfare.

## 2. WINNERS

- 2.1. The winner will be decided by an online public vote hosted on the Racing Welfare and/or the Henry Cecil Open Weekend website between the **18 20 September 2020.** Votes will be restricted to one per IP address. The winner will be the commentary that garners the most votes polled. In the event of a tie in the final, the finalist who raises the most amount of money on their JustGiving page will be deemed the winner.
- 2.2. Winners will be announced live on Racing TV on **20 September 2020** and notified officially by email. They will be asked to confirm their details for delivery of the prizes.

# 4. THE PRIZES

- 4. There is a total of two prizes available to be won:
  - Overall winner will receive: (a) £1000 tax free and (b) The chance to commentate live at Newmarket Racecourse during the Henry Cecil Open Weekend 2021 (c) an official Henry Cecil Open Weekend Commentator Challenge Trophy.
  - ii. Top fundraiser, based on funds raised through their JustGiving Page, will receive: (d) A day behind the scenes at Racing TV in 2021.

# 5. **CONDITIONS**

2. In the event that the promoter is unable to contact a winner within 10 working days of the relevant draw, the promoter reserves the right to award the prize to the person to have placed second within the final poll.



- 3. The £1000 prize will be delivered within 28 working days from a valid acceptance of the prize.
- 4. The opportunity to commentate at Newmarket Racecourse during the Henry Cecil Open Weekend 2021 will be subject to government and racecourse guidelines.
- 5. The prize for the top fundraiser (d) is subject to government and Racing TV corporate guidelines. Date to be mutually confirmed by Racing TV and the winner.
- 6. No cash alternative. Prizes are non-transferable and cannot be resold. The promoter reserves the right to substitute an alternative prize of equal or greater value.
- 7. Each entrant agrees to take part in reasonable publicity as may be required by the promoter in respect of the promotion.
